Subject: PROJECT STATUS REPORT

Summary

The report provides commentary on the Transforming Jetty Road Status Report for the July to August 2024 period. The aim of the report is to provide information on the status of the project, how it is tracking towards expected outcomes, current and future activities, key risks and issues emerging, current stakeholder engagement activities, and project finances.

Recommendation

That the Transforming Jetty Road Committee notes the report.

Background

The aim of the project is to deliver the remaining three zones of the Jetty Road Masterplan, namely the Coast, Transition and City Zones over the next three years. The delivery includes concept design development, detailed through to construction.

The delivery of the project will be undertaken by sequencing the design development and construction by Zones, starting with the City Zone, followed by the Coast Zone and then the Transition Zone.

Project Risks

The project's financial status has changed from amber to green now that Council has allocated a \$10 million budget for the 2024-25 period. The Committee should note that as we move towards next financial year's annual business plan and budget the rating will likely change to reflect the project's cyclical funding. The project's schedule, risk/issues and scope are all rated green and are tracking as expected.

City Zone Design Development

The project has continued to develop the City Zone's designs. The draft City Zone concept plans have been approved by Council for further development and investigation prior to finalising the plans and releasing them to the wider community in early October 2024.

Entrance Statement and Public Art

A workshop was held with Elected Members on 13 August to determine the design parameters for the Entrance Statement and associated public art. The workshop included a presentation by the selected Artist, Skunk Control. From the workshop, a Project Brief for the Entrance Statement and associated public art is being finalised. A summary presentation and feedback will be undertaken with the Committee on 11 September 2024. As concept development progresses this will be shared with the Committee and Elected Members.

Meetings with Businesses

The draft City Zone plans are currently being shared with the businesses on Jetty Road and the overall feedback has been positive. The businesses within the City Zone have also been providing the operational requirements during these meetings. This information will be included in the construction planning.

Procurement

The Select Tender Early Contractor Involvement (ECI) procurement has closed with all four selected companies submitting a proposal. The evaluations have been undertaken and Outside Ideas Pty Ltd and Blubuilt Pty Ltd have been selected to participate in the constructability advice workshops. These workshops commenced on 9 September 2024.

Paver trial

The paver trail which will feature the new Urban Stone Fleece engineered paver will be installed near the Telstra building on the southern side of Jetty Road. The work commenced on Saturday 7 September and will be completed on Wednesday 11 September 2024.

Due to the location of the trial, there are no anticipated access issues or disruption to the businesses along the street or the street's operation. The trial area is approximately 20 square metres.

Businesses have been encouraged to visit the area and provide feedback. Council staff will undertake cleaning activities to assess the pavers' wearability and cleaning requirements.

City Zone Risks and Emerging Issues

Trees

The project is investigating design risks related to the installation of the palm trees in the City Zone, due to their proximity to third party infrastructure. A separate report has been tabled for the Committee's consideration at the 11 September 2024 meeting.

Stormwater

The stormwater CCTV investigations have been analysed and shown that the pipes in the City Zone require replacement. The project is currently investigating non-invasive/low disruption options to resolve this issue. It is likely that re-sleeving the existing pipes will mitigate the damage and re-set the asset's life.

Coast and Transition Zones Design Development

The Coast and Transition Zone design work is commencing with a focus on preparing traffic plans. The process will commence with iterative discussions with the Committee and Council regarding traffic operation options before the plans are finalised and shared with the wider community for their feedback.

Construction activities

Construction activities in the City Zone are on track to commence in Spring this year. The Coast and Transition Zone construction program is currently being reprogramed to align with the Department of Infrastructure and Transport's grade separation work, which includes the cessation of tram services from August 2025 to January 2026. This closure has recently been confirmed and the project will seek to take advantage of the tram closure and align the construction program accordingly.

Future activities

Design development and construction planning will continue for all three zone and include feedback from the Committee regarding the presentations undertaken on 11 September 2024.

Budget

Financials within the status report show the budget for the project over the future financial years.

Strategic Plan

The Transforming Jetty Road Glenelg Project aligns with the strategic goals of the City of Holdfast Bay, and objectives and outcomes sought in State and Commonwealth Government plans, contributing to economic growth, community wellbeing, and the promotion of tourism.

Current Project Status Summary

Financials: Change in risk from amber to green as the 2024-25 Business Plan and budget has been approved by Council and \$10 million of funding has been allocated for the deliverables of this financial year's scope of work. The ECI procurement has been finalised and the contracts awarded to Outside Ideas Pty Ltd and Blubuilt Pty Ltd. This work is now underway.

Concept plans for City Zone are currently being finalised to be released to public on 9 October 2024. Construction in the City Zone is on track to commence late October.

Coast and Transition zone concept planning has progress with traffic analysis options being prepared for discussion with this Committee and Elected Members.

Paver trial has been installed near the Telstra building.
