At its meeting held on 28 April 2022 the Alwyndor Management Committee (AMC) considered a proposal to establish a loan facility with the Local Government Finance Authority (LGFA) to enable Alwyndor to meet the requirements of its Refundable Deposits Liquidity Management Strategy and Policy whilst maximising its investments consistent with its Investment Strategy.

AMC resolved that it: recommends in principle the loan facility application with the Local Government Financing Authority subject to the addition of an approval

process to the Refundable Deposits Prudential Standards, Liquidity Management Strategy and Policy, Audit Committee review and Council approval.

At its meeting held on 26 May 2022 AMC will consider an amendment to the Policy to enable such a loan application. Audit Committee will be updated at its meeting regarding the outcomes of this meeting.

This report seeks Audit Committee consideration of this matter and recommendation of its approval to Council.

On Monday 21 March 2022 a Business Case to insource Catering Services for Alwyndor was considered and supported at a special meeting of the Alwyndor Management Committee (AMC). Subsequently Council considered this matter at its meeting held on 12 April 2022 and approved the recommendation.

Alwyndor is committed to providing excellence in its residential services and recognises the importance of food, nutrition and the dining experience as an integral part this commitment. A review of Alwyndor catering services has identified issues of concern in relation to quality, presentation and nutrition, as well as inefficiencies with the current service model. A business case has been prepared to move catering services in-house with the aim of increased control over the service model and increased food satisfaction and quality. This aligns with two of Alwyndor's strategic actions:

- Customer Experience: Implement enhanced dining experiences
- Customer Experience: Develop hospitality training for carers.

This report offers a summary of the work undertaken, informs Audit of AMC and Council recommendations regarding the new catering model and the approval granted by Council to bring forward associated capital funding for the project. The Business Case can be provided in its entirety if required.

Subsequent to the AMC consideration of the Business Case Vision Food Services (Vision) notified Alwyndor on of its intention not to seek renewal of its contract from 30 June 2022.
