#### **SUMMARY**

The Terms of Reference for the Alwyndor Management Committee require Council approval for the appointment of members upon completion of a three year term (for up to three terms).

Mr Kim Cheater has been a member of the AMC since June 2017 and is eligible for another three year term. Mr Cheater has indicated he is willing to be reappointed. Following the appropriate process to engage and seek necessary approvals by the Committee, this report seeks Council approval for Mr Cheater's reappointment for a further term.

#### RECOMMENDATION

1. That Council reappoints Mr Kim Cheater to the Alwyndor Management Committee for a term of three years to expire on 31 July 2026.

#### **REPORT**

Membership of the Alwyndor Management Committee (AMC) is appointed on a 'rolling basis' as members complete their terms. New appointments can involve either new members and/or the re-appointment of existing members.

Mr Kim Cheater has been a member of the Alwyndor Management Committee since July 2017 and Chair since 2019. Mr Cheater is eligible for another three year term noting this will be the final term he is able to hold under the Terms of Reference. AMC members are eligible for a maximum of three, three year terms.

In discussion with Chief Executive Officer, Mr Roberto Bria, Mr Cheater has indicated he is willing to be reappointed.

The process for reappointment is guided by the Terms of Reference as follows:

# Membership

- 8.1.3 On expiry of their term, members of the AMC may seek reappointment. The Chief Executive Officer, the Chairperson and one of the appointed Elected Members will consult and make a recommendation to Council who will decide on the reappointment.
- 8.1.4. An AMC member may only serve a maximum of three consecutive terms.

Consistent with this process and given that Mr Cheater is currently Chair of the AMC, the Chief Executive Officer, Mr Roberto Bria, Councillors Susan Lonie and Robert Snewin (Council nominated Elected Members on AMC) have engaged and have unanimously supported Mr Cheater's reappointment.

It has been expressed that Mr Cheater continues to bring value to the AMC and brings an important historical perspective given the longevity of his term on the AMC. It was also noted that Mr Cheater works well with the other AMC members and has performed very effectively in his role both as a Committee Member and as Chair.

The position of Chair will be considered by the AMC at its meeting to be held on 27 July 2023 and a recommendation will be brought to Council for consideration and approval.
