2.1	<p><b>Commonwealth Community Development Grant for the Southern Materials Recovery Facility</b></p> <p><b>Summary</b> - The Deputy Prime Minister has approved grant funding of \$5.35m from the Commonwealth Community Development Grant Programme to support the construction of the Southern Materials Recovery Facility (SMRF). The funding agreement is currently being finalised and the CEO is sought Board approval to finalise the drafting of the agreement and sign the final form of the agreement.</p>
2.2.2	<p><b>Acquisition of Land Adjacent to South Road</b></p> <p><b>Summary</b> –A 1.159 ha portion of SRWRA owned land fronting Main South Road has been compulsorily acquired by the Government of South Australia Department for Infrastructure and Transport (DIT) for the purpose of the Main South Road Duplication Project. The Board authorised the CEO to sign the Post – Acquisition Accommodation Works Deed.</p>
3.2	<p><b>Chief Executive Officers Information Report</b></p> <p><b>Summary</b> – The opening of the Southern Materials Recovery Facility (SMRF) is in the planning stage and is subject to input from the Commonwealth. All information regarding the facility is embargoed until the opening as part of the funding agreement with the Commonwealth however business development activities are continuing in order to attract new customers.</p>
