### 3P EXEMPTION PERMIT CONDITIONS

1. **The permit must be attached to or displayed at the bottom passenger side of the vehicle windscreen so as to be clearly and completely visible from outside the vehicle.** Expiation notices issued resulting from incorrectly or failing to display the permit may not be withdrawn.
2. Issue of permits is subject to payment of a \$162.00 fee per permit, which is applicable from date of receipt of application until expiry, which is 30 June each year. The fee is not refundable if the applicant ceases to reside at the address contained in the application. The permit will need to be returned to Council.
3. A \$15 administration fee will apply for the reissue of a lost or damaged permit. The request will need to be made in writing for a replacement
4. The applicant is responsible for proving occupancy of the property shown on the application and proving ownership of the vehicle which will display the permit.
5. Issue of a permit is subject to there being insufficient off street parking available at the applicant's address and if required, the applicant may be required to allow Council officers access to the property to inspect to confirm this.
6. The permit only allows a vehicle to be parked in excess of the time limit in 3P (three hour time limit) areas in Glenelg, it does not allow exemption from any other timed parking restrictions or to contravene other Australian Road Rules or to remain parked for an extended period of time without moving.
7. The permit applies only to vehicles of persons residing or staying at the applicant's property, as shown on the permit application form.
8. Breach of these conditions or misuse of the permit may result in cancellation of the permit.
9. Council may change the conditions applicable to permits with reasonable notice.
